This is a reading seminar designed to consider recent scholarship on empire and gender in Africa, Latin America and Asia. The theme is heterogeneity: in theoretical conceptualization, methodology, empire, and chronology. The works to be read approach the question of empire and gender in very different ways, allowing us to draw from and criticize many ways of understanding maleness and femaleness in the context of imperialism and colonialism.

Requirements:

- 1. Attendance
- 2. Weekly reaction papers
- 3. An individual project negotiated with the professor

Attendance is required, obviously; please inform the professor before class of any planned or unplanned absences.

Weekly reaction papers are informal. Normally they would be one page or two in length (single space) which you a) summarize the argument of the monograph in a short paragraph of 3-4 lines; b) jot down your comments to particular points raised in the reading; c) raise 3-4 questions/issues for seminar discussion. In your weekly reaction papers, please try to compare and contrast the current reading with previous ones. Reaction papers will be collected after class by the professor and will serve as a springboard for in-class discussion. No reaction papers will be accepted after the seminar has met.

Individual projects are negotiated individually with the professor and should be designed to further your current research, writing, academic interests/program/fields etc. The nature of "projects" can vary widely, depending on your needs. Please contact the professor individually to discuss what would work best for you.
